

Boatboys is responsible for the processing of personal data as stated in this privacy statement.

## Personal data that we process

Boatboys processes your personal data because you use our services and / or because you provide this data to us yourself. Below you will find an overview of the personal data that we process (if provided to us):

- First and last name
- Address data
- telephone number
- E-mail address
- IP address

## Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors under the age of 16. Unless they have permission from parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, to prevent data about children being collected without parental consent. ## For what purpose and on what basis we process personal data

Boatboys processes your personal data for the following purposes:

- Processing your payment / order
- To be able to call or e-mail you if this is necessary to be able to perform our services

## Automated decision making

Boatboys does not make decisions about cases based on automated processing that may have (significant) consequences for individuals. These are decisions that are made by computer programs or systems, without a person (for example, an employee of Boatboys) in between.

## How long we keep personal data

Boatboys do not store your personal data for longer than is strictly necessary to achieve the purposes for which your data are collected. We use the following retention periods for the personal data: Personal data> Retention period of 5 years (after the collaboration ends). Legal obligations can lead to a different, longer retention period.

## Sharing of personal data with third parties

Boatboys only provided to third parties and only if this is necessary for the implementation of our agreement with you or to comply with a legal obligation.

## Cookies, or similar techniques, that we use

Boatboys uses only technical and functional cookies. And analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferences. We can also use this to optimize our website. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that was previously saved via the settings of your browser. More information about switching on and off and removing cookies can be found in the instructions and / or with the help function of your browser.

## Use of session cookies

With the help of a session cookie we can see which parts of the website you have viewed during this visit. We can therefore adjust our service as much as possible to the surfing behavior of our visitors. These cookies are automatically deleted as soon as you close your web browser.

## Analytics and Google Ads

A cookie is placed via our website from the American company Google, as part of the Analytics service. We use this service to keep track of and get reports on how visitors use the website. Google may provide this information to third parties if Google is legally required to do so, or insofar as third parties process the information on Google's behalf. We have no influence on this. We have allowed Google to share visitor information with Google Ads, for tracking visits via Google Adwords campaigns.

The information that Google collects is made anonymous as much as possible. Your IP address is explicitly not given. The information is transferred to and stored by Google on servers in the United States. Google adheres to the Privacy Shield principles and is affiliated with the Privacy Shield program of the US Department of Commerce. This means that there is an appropriate level of protection for the processing of any personal data.

## View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw any consent for data processing or to object to the processing of your personal data by Boatboys and you have the right to data transferability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to [info@amsterdamprivateboat.com](mailto:info@amsterdamprivateboat.com).

To ensure that the request for inspection has been made by you, we request that you send a copy of your proof of identity with the request. Make in this copy your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen service number (BSN) black. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.

Boatboys would also like to point out that you have the option to file a complaint with the national data protection authority, the Dutch Data Protection Authority.

## How we protect personal data

Boatboys takes the protection of your data seriously and takes appropriate measures to prevent abuse, loss, unauthorized access, unwanted disclosure and unauthorized changes.
